

Privacy Policy

Your privacy is very important to us. We ("Viedit") set up this policy to help you ("User") understand how we collect, protect, use and communicate your personal information.

The following outlines Viedit's privacy policy. Viedit operates in accordance with these principles to ensure that the confidentiality of your personal information is protected and maintained.

A. Information we collect from you

A.1 Personal identification information

During the registration process of either a client or an editor account, you may encounter that the following information is necessary in order to create a profile:

- Name
- E-mailaddress
- Country
- Language
- Date of birth

Furthermore, all Users have the freedom to submit extra information, such as:

- Social media account information to sign up or post movies
- Creditcard information for Clients
- Bankaccount information for Editors
- YouTube and Vimeo account details for Editors

Please note that sometimes more personal identification information is needed to engage in certain website-related activities.

A.2 Non-personal identification information

We may collect non-personal identification information from you while you interact with our website. This type of information are part of website analytics, such as:

- The name of your browser
- Geographical information
- Pages visited

B. Editors can control the information they share on their profile

From the control panel on the Editor's account, the information that can be shared is managed. Please note that there are some mandatory fields to be filled in. They are marked by an asterisk.

C. What we do with the information we gather

C.1 To personalize user experience

We may use the collected information mentioned in section A to understand how Viedit's Users use the website's service and resources.

C.2 To improve our website

We continually strive to improve our website and our service towards Viedit's Users, based on the information and feedback we receive from you.

C.3 To improve customer service

The information you supply, helps us to respond more effectively to your customer service requests and support needs.

C.4 To process transactions

We may use the information Users provide about themselves when placing an order only to provide service to that order. We do not share this information with outside parties.

C.5 To contact you periodically

The email addresses you provide for order processing, will only be used to send them information and updates pertaining to their order. It may also be used to respond to your inquiries, and/or other requests or questions.

If you decide to "opt-in" to our mailing list, they will receive emails that may include company news, updates, related product or service information, etc. If at any time the User would like to unsubscribe from receiving future emails, we include detailed unsubscribe instructions at the bottom of each email.

D. Your personal data is safe with us

D.1 How we protect your personal data

We adopt appropriate data collection, storage and processing practices and security measures to protect against unauthorized access, alteration, disclosure or destruction of your personal information, username, password, transaction information and data stored on or through Viedit. Sensitive and private data exchange between the Viedit website and its Users happens over a SSL secured communication channel and is encrypted and protected with digital signatures.

D.2 We do not

We do not sell, trade, or rent your personal identification information to others. We may share generic aggregated demographic information not linked to any personal identification information regarding visitors and users with our business partners, trusted affiliates and advertisers for the purposes outlined above. We may use third party service providers to help us operate our business and the website or administer activities on our behalf, such as for payment transactions. We may share your information with these third parties for those limited purposes provided that you
